## **PRESIDENT'S REPORT**

Dear Members,

In what is my 4th and final President's Report I want to take this opportunity to firstly thank our entire membership for their continued commitment to the game - from our members running out several times a weekend, on birthdays, Mother's and Father's Day as well as many other times that may be an inconvenience, right through to our Members who represent us on the World Stage, the QRRRA is without doubt a shining light in Match Officiating across the board in the Australian Rugby Landscape.

Looking back since I first joined the Management Committee in 2016 there are so many things "QRRRA" that stand out. Most of which I am immensely proud of, some are frustrating and some I hope no Committee Member ever have to deal with again. I am confident that more so than ever the QRRRA is an association that is welcoming and feels like our own 'club' than it has at any time in my 26 years of membership. It is encouraging to see the number of young members joining our ranks and finding a passion to be a part of the game as a Match Official, and equally encouraging to still see so many of our members, as recognised later in the report, involved and contributing to the game for more than 100, 250, 500 and even 1000 games as well as years of service that are seriously impressive.

The importance of recruitment, education and retention continue to be in the spotlight - and 2025 was a positive step in that with support of the QRU employing a dedicated Match Official resource for the first time in well over a decade! Having Dan Mangin in that role, who has a close and strong connection to Match Officiating and the QRRRA as a member, is seeing great outcomes in this space and its encouraging for the future. Further to this, the support of Match Officials around inclusiveness and protection from abuse and poor behaviour from the QRU and most competitions who engage our services in 2025 has seen a significant step up. While we still have seen some incidents occur, and likely always will in some respect, the responsiveness, follow up and follow through has been noticeable and appreciated. What goes hand in hand with this is the relationships that the QRRRA has with our stakeholders. Our engagement with, again, most competitions we are involved in are excellent. Various members of the Management Committee have taken on the task across Seniors, Juniors, Subbies and most of the Schools competitions, with the latter being the only ongoing concern in one instance which is an outlier to the rest of the good work and collaboration.

During the season the QRRRA continues to represent across every level of the game - grassroots all the way through to World Rugby Appointments. With our long-standing professional group of referees, Nic Berry, Damon Murphy, Jordan Way and Reuben Keane performing strongly time and time again - along with Jess Ling representing proudly at the Women's RWC in England. We also see Brett Cronan continue to be heard from the TMO box and Rachel Horton also being selected in that role for the WRWC. Coming through its still a regular sight of George Meyers and Jeremy Markey on the sidelines in Super Rugby and on the world stage as well as in the middle along with so many of our other members

who have earned opportunities in underage Super Aus competitions and more local representative appointments.

2025 sadly saw us lose probably one of the most iconic QRRR members known in the Qld Rugby landscape - Peggy. Life Member Geoff Pegg was a consistent face on the sidelines and in the background administration of QRRR Members for decades. His active involvement really only slowed down this year, and it came as a very sad shock to hear of his tragic passing. A testament to Geoff was the turnout at his funeral - that saw past members of the QRRR and wider rugby community come together for the first time in a lot of cases in more than 10 years. He was loved by many, feared by me but respected by all for his passion, commitment and dedication to others in the game. Rest In Peace, Peggy!

To our Admin Officer, Nick Joseph; Appointments Officers, Neill McCann and Scott Chapman - a huge thank you for your continued work for the QRRR and its members. A lot goes on behind the scenes, and while the job seems impossible sometimes through your commitment we get there and continue to find ways to do it better and ensure that our members are afforded the opportunity to participate and develop. To Cam Stanfield, Paul Marks, Paul McKay and Ben Dorrington-Plumb, your leadership and work across the various squads and groups in terms of performance and development has been excellent and so many of our members would agree - the results speak for themselves! Thank you for your commitment to this.

I would also like to thank the fellow Management Committee Members who have made up a team of people to get the QRRR organisationally where it is today. Everyone brings a unique ability to cover tasks needed done and see the game roll on - thank you all for your work.

Our Sponsors - Chemist Warehouse, TFH, Canterbury - we are appreciative of your backing to ensure our members not only have kit but development opportunities and activities that bring us together which is only possible because of your support.

Thinking over the last 9 years I have been volunteering in Committee Roles it's striking to me how much work so many people have put in to get where we are today. Both organisationally and performance wise on the field I am confident that it is very much noted from Rugby Australia all the way down that QRRR is a leader.



## **APPOINTMENTS OFFICER'S REPORTS**

### **Senior and School Appointments**

I feel privileged to undertake the role of Appointments Officer for our Senior grades and Schools competitions. The Appointments function is very much the public face of our Association – internally, it is part and parcel of what our members do (i.e., the 'bread and butter' of our activities), and externally, it represents where we fit into the rugby community and, therefore, how we are evaluated and gauged at these levels. Bottom line is that its importance cannot be understated, and members need to be aware that it is not just their peers who are looking at the appointments with the rest of the rugby community taking an active interest. The advent of the digital age means that virtually every game is available to be viewed and potentially evaluated.

The challenges we faced this year were not significantly different from those in prior seasons, but that doesn't mean they were any easier to handle. Detailed below are some of these:

- The gap between 'seasons' is becoming increasingly harder to distinguish with the rugby calendar running longer and longer with kick off for trial games for community rugby from early February (and representative seasons even earlier) and 7s tournaments and speciality carnivals fully entrenched until late November. This means escalating fatigue among referees, resulting in many referees and referee coaches at all levels being unavailable or suffering injuries.
- There is a double-edged sword with increasing numbers of representative fixtures, particularly in what was the traditional off-season. It is pleasing that many of our members are receiving appointments (including support roles) at these levels; however, our own resources are then not available to referee 'our' games. The upside is that our remaining members then get to step up to higher level fixtures.
- We remain fully taxed during the peak part of the season. Realistically, there is a shortage of approximately 30 more experienced referees to meet all of our requirements. This means our primary way of addressing this is for our members to step up and take on additional appointments. We predominantly do this with the shorter duration school games rather than club fixtures.
- Several referees are electing to referee the lower-grade school games in preference to the games for the A's, with the remuneration being a major factor.
- We are also increasingly being requested to appoint further afield, particularly to more games in the Gold Coast, Darling Downs and Ipswich areas. The payment of a fuel subsidy over and above match payments has made these more palatable for members. We now also have regular formal competitions on Wednesday, Thursday and Friday nights.
- Interchange international and interstate programs are now again fully operational, with these enhanced by internal interchanges providing opportunities for our referees to referee A-grade games in our local neighbour competitions on the Darling Downs, Sunshine Coast, Gold Coast and Far North Coast NSW. This also provided development opportunities for referees from the Country Associations to participate in our competitions. Solid workable relationships with their respective Appointments Officers have made this very workable.
- There are now a significant number of competitions being run during the working week, and we continue to rely on a few valuable referees who can free themselves to assist.
- The Rugby Xplorer system we utilise to administer the appointment systems has shortcomings, resulting in significant manual input. The system also lacks a notification function when changes are made by Competition Managers (eg changes in venues or game times). Whilst there have been enhancements, further work is required to streamline functions to make them more user-friendly.

A couple of major developments have been very positive.

- We have fostered the relationship with the Queensland Country Rugby Referees Association, which provides an enhanced joint platform to manage and lead the various Championships and representative fixtures throughout the State. I particularly wish to acknowledge the invaluable contribution of my fellow Appointments Officer, Ian McGowan, to make this so workable at an operational level from both Associations' perspectives.
- The further enhancement of the Pathways program under Ben Dorrington-Plumb, including the work undertaken by Paul McKay with the Transition Squad, has enabled referees to be moved into Grade and Colts football in a far more functional manner.

Lastly, there are a number of people that I want to pass on my thank you:

- Thanks to the Appointments Board (Cameron Stanfield (Chair), Paul Marks and Shane Barr) as well as my fellow Appointments Officer, Scott Chapman and Administration Officer, Nick Joseph, for your ongoing support.
- Thank you to all the referee coaches for the feedback provided to referees (and particularly back to me) – this feedback is an invaluable assistance in the appointment processes.
- Thank you to our stakeholders and competition managers for your assistance, particularly Connor Ellis, who has now farewelled the QRU, as well as the Coordinators of the school-based competitions (Jodie, Ashya, Eddie and Jay).
- Lastly and most importantly, Thanks to our valuable members, particularly those who have been very flexible in providing assistance to meet our workloads, particularly early on Saturday mornings!

I look forward to working with you all in season 2026.

I am deeply appreciative of the solidarity shown by QRRR referees in the junior ranks and thank them for being committed to officiating multiple games in one day, showcasing their dedication and passion for the sport. My thanks and appreciation to all the referees in the junior pool, and those who rose to the occasion when needed, ensuring the success of our junior games.

I am looking forward to working with all our referees in 2026.

NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act Queensland. The management committee has determined that the association is not a reporting entity.

All revenue is stated net of goods and service tax (GST).

Donations are recognised when the cash is received



**Opinion**

We have audited the financial report, being a special purpose financial report, Queensland Rugby Referees Association (Brisbane) Inc. which comprises the income and expenditure statement, the balance sheet as at 30 September 2025, the statement of changes in equity, a summary of significant accounting policies, other explanatory notes and the statement by members of the committee

In our opinion, the financial report presents fairly, in all material respects the financial position of Queensland Rugby Referees Association (Brisbane) Inc. as at 30 September 2025 and the results of its financial performance for the ye then ended in accordance with the financial reporting requirements of the Associations Incorporation Act Queensland.

**Basis for Opinion**
